POLICY TITLE: Sustainability

A. Background

Niagara College – Toronto is dedicated to taking a leadership role in environmental sustainability. We know that our employers expect this knowledge from our graduates and believe that it is critical to their future success.

B. Purpose

Niagara College - Toronto will continue to develop a culture of sustainability and integrate our knowledge within the College community. This policy will serve as a driving force to support the growth of sustainability development for the College.

C. Scope

This policy applies to all Niagara College students registered and attending classes at the Niagara College - Toronto campuses.

D. Policy Statements

- 1. Niagara College Toronto will actively contribute to the restoration of the environment and the conservation of natural resources by implementing and promoting sustainability-based principles such as reduction, reuse, recycling, and recovery in its operations. The College's corporate sustainability practices will be guided by/incorporate the following:
 - a) Apply consistently to all geographic locations.
 - b) Become an integral part of current College operations through organizational structure, resource allocation and training.
 - c) Ensure that the acquisition and disposition of materials will conform to environmentally friendly guidelines.
 - d) Apply reduction strategies relating to energy and material usage in College operations.
 - e) Apply reuse, recycle, recovery strategies for materials, commodities, and capital items.
 - f) Promote environmental consciousness to students, staff, and clients; and
 - g) Recognition of students and staff for their sustainability efforts.

 - g) Work towards monitoring and measuring our progress to report on it periodically.
